## Guide to the Special Benefit for Supporting Families with Children

A new benefit is being provided to support families with children!

## 1. Eligible Recipients

Those to whom both (1) and (2) apply

(\* Excluding those who have already received the single-parent household benefit)

Fathers and mothers and the like with <u>children</u> who were <u>under age 18</u>, as of March 31, 2021, (<u>under age 20</u> if they have special needs)

(\* Newborns born through the end of February 2022 will also be covered.)

Those who <u>are exempt</u> from the <u>Resident's Tax (per capita)</u> for FY 2021,

or

Those whose incomes changed suddenly on or after January 1, 2021, and became equivalent to levels exempt from Resident's Tax.

## 2. Payment Amount

## Flat rate of 50,000 yen per child

Application is not required to receive this benefit in some cases but is required to receive it in others



## 3. Benefit Payment Procedures

- I. Those who received a <u>Child Allowance or Special Child Rearing Allowance</u> in April 2021 and who are exempt from paying <u>Resident's Tax</u>
- Do not need to apply to receive this benefit.
- Local municipalities will transfer the benefit to their bank accounts where they received the Child Allowance or Special Child Rearing Allowance for April 2021 as soon as possible.

### (Warning)

- Please return the refusal notification form if you do not wish to receive the benefit.
- Please take steps to change your designated account if it is possible that the
  payment of benefits may be affected by acts such as the closure of the account
  designated for the payment of the Child Allowance or Special Child Rearing
  Allowance.
- II. Those other than the above (those raising only high-school age children or whose incomes have fallen suddenly)
- Do need to apply to receive this benefit.
- ➢ Please fill in the destination bank account information on the application form and submit it along with the required documents directly to the reception of your local municipality or by mail.
- Application details will be confirmed, and bank account transfers of the benefit will be made to the designated accounts of those meeting the requirements for benefit payments.
